CAMDENFORWARD SCHOOL IS A PRIVATE, CHRISTIAN ELEMENTARY AND MIDDLE SCHOOL SERVING STUDENTS AT THE KINDERGARTEN THROUGH EIGHTH GRADE LEVELS. WITH A LEARNING ENVIRONMENT RICH IN LOVE, HOPE, AND STRUCTURE, THE SCHOOL CHALLENGES STUDENTS TO ATTAIN HIGH ACADEMIC STANDARDS, LEARN NECESSARY LIFE SKILLS, MAINTAIN PERSONAL INTEGRITY, AND DEVELOP A CHRISTIAN WORLDVIEW. IN 1997 THE SCHOOL OPENED WITH ONLY TWO CLASSES: PREKINDERGARTEN AND KINDERGARTEN. URBANPROMISE ESTABLISHED AN ADDITIONAL GRADE LEVEL EACH YEAR THEREAFTER UNTIL ALL ELEMENTARY AND MIDDLE SCHOOL CLASSES WERE AVAILABLE. CAMDENFORWARD SCHOOL NOW SERVES APPROXIMATELY 130 STUDENTS FROM CAMDEN AND THE SURROUNDING AREAS. DYNAMIC MUSIC, PERFORMANCE AND FINE ART, AND PHYSICAL EDUCATION PROGRAMS SUPPLEMENT A COMPREHENSIVE ACADEMIC CURRICULUM. IN THE PAST

IN ADDITION TO THE AFTER SCHOOL PROGRAM, URBANPROMISE'S YOUTH MINISTRY INCLUDES THE STREETLEADER PROGRAM WHICH OFFERS EMPLOYMENT TO CAMDEN AREA TEENAGERS TO WORK AS COUNSELORS, TUTORS, MENTORS, DISCIPLINARIANS, AND ROLE MODELS FOR MORE THAN 400 CHILDREN IN OUR AFTERSCHOOL PROGRAMS AND SUMMER CAMPS. STREETLEADERS ARE ENCOURAGED TO STAY IN SCHOOL, ATTAIN JOB SKILLS, AND AVOID NEGATIVE LIFE CHOICES SUCH AS EARLY PARENTHOOD, DRUGS, AND THE PENAL SYSTEM. A NATURAL OUTGROWTH OF THE AFTERSCHOOL PROGRAM, THE STREETLEADER PROGRAM HIRES APPROXIMATELY 80 TEENS EACH YEAR, MANY OF WHOM ARE GRADUATES OF THE AFTERSCHOOL PROGRAM. STREETLEADERS ARE PASSIONATE ABOUT THE OPPORTUNITY TO MENTOR THE NEXT GENERATION OF CAMDEN YOUTH AND GIVE BACK TO THE COMMUNITY. IN FACT, THE HEART OF THE STREETLEADER PROGRAM IS CHALLENGING TEENS TO USE THEIR
